- Certificate course of fifteen days from any State Agricultural University OR Krishi Vigyan Kendras OR National Institute of Agricultural Extension Management (MANAGE) OR National Institute of Rural Development and Panchayati Raj (NIDPR) OR Fertilizer Association Of India or any other Government approved Institute.
- Provided that a person in possession of Bachelor of Science in Agriculture OR Chemistry OR Diploma in Agriculture Science from a recognized University or Institute or equivalent course having one of the subject on Fertilizer or Agri Inputs, as notified by the State Government shall not be required to possess separate certificate course.
- Provided further that a dealer who has been granted authorization letter before commencement of the Fertilizer (Inorganic, Organic or Mixed) (Control) Fourth Amendment Order, 2018 shall not be required to possess the qualification at the time of renewal of their authorization letter.
- Provided also that the said qualification shall not be applicable for renewal of the authorization letter of the registered Agricultural Cooperative Societies and State Marketing Federations subject to conditions that such Society or Federation shall engage a person who possesses the qualification under this clause.
