Notification

1. In compliance with the order dated 11th August, 2010 of the Hon'ble Punjab and Haryana High court in CWP No 8828 of 2010 a Committee was constituted to inspect/test the land of the petitioners and other adjoining regarding the nature of water logging in terms of "Punjab preservation of Subsoil Water Act,2009

2. On the basis of the report of the committee notification no 8/19/2006-Agri 2(6)/4190 dated 11-04-2011 was issued to declare the land of 23 villages of Sri Mukatsar Sahib as water logged under section 3(3) (c) and the area of these villages was exempted from the purview of the "Punjab Preservation of Sub –soil water Act,2009", for a period of 2 years. This was exempted further for a period of 2 years vide notification no 8/19/2006-Agri 2(6)/6152-6163 dated 16-05-13 and notification no 8/19/2006-Agri/-2(6)/4088 dated 14-05-15

3. As per provisions of the notification after two years, these villages were again inspected/ tested by the committee and on the basis of report of the committee and proposal of the Director Agriculture Punjab, the Governor of Punjab is pleased of declare the land of the following villages of Sri Mukatsar Sahib district as water logged under section 3(3)(c)and the areas of these villages is exempted from the purview of the "Punjab Preservation of Subsoil water Act,2009",for period of 2 years:
