Chandigarh, dated the 20'03 2023 Whereas, preliminary notification no. 25/14/2025-Agri-4(2)/6020, dated 21.06.2022 was issued under Section 11 of "The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013" for acquisition of land for the public purpose namely "Establishment of the Post Graduate Institute of Horticulture Research and Education (PGIHRE) at Village Chhidan, Hadbast No.333, Tehsil Lopoke, District Amritsar a piece of land measuring 12.00148 Hectare (29Acre 5 Kanal 5 Marla)."

The Notification U/s 11 was got published in the Punjab Government Gazette dated 08.07.2022 and in the two daily newspapers "The Tribune" (English version) dated 14.07.2022 and "Ajit" (Punjabi version) dated 14.07.2022 The Public Notice regarding the substance of this notification in local language (Punjabi) was got published in the locality as per Rapat No.394 of the Roznamcha register of the Halqa Patwari of the Patwar Circle, in the office of District Collector, Amritsar. This notification was also uploaded on the website on 05.07.2022 of Department of Agriculture and Farmers Welfare, Government of Punjab and Department of Horticulture, Sahibzada Ajit Singh Nagar, Punjab.

Whereas, Government of Punjab is satisfied that the land specified above is needed by the Government at public expenses for public purpose, namely Acquisition of land for establishment of "Post Graduate Institute of Horticulture Research and Education (PGIHRE) at Village Chhidan, Hadbast No.333, Tehsil Lopoke, District Amritsar a piece of land measuring 12.00148 Hectare (29Acre 5 Kanal 5 Marla)." In this connection, based on the census survey of affected families, a Rehabilitation and Resettlement Scheme was prepared as per provisions of Section 16 of the said Act, by the Additional Deputy Commissioner Cum Administrator. Rehabilitation which has been reviewed by the Collector as per provisions of Section 17 of the Act.

Whereas, the intended acquisition of the proposed land, probabilities of displacement of the affected families are nil. However, the Additional Deputy Commissioner (G), Amritsar was appointed as Administrator for the purpose of rehabilitation and resettlement of the affected families, who, in compliance with section 16 of the Act, submitted its Survey report No.DRA(M)/A-2/1465 dated 30.11.2022 along with compete record, whereupon the learned Commissioner, Jalandhar Division, Jalandhar has also pleased to approve the Rehabilitation and Resettlement Scheme, vide its letter No.DA-2023/1074 dated 21.02.2023 and the same has also been published in compliance with mandatory provisions as envisaged U/s.18 of the Act.

This declaration is made after hearing of objections of persons interested and due enquiry as provided under Section 15 of the Right to Fair compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013). Since no one is likely to be resettled due to the aforesaid land acquisition, thus, no resettlement area is required to identified, in this regard.

This declaration is made under the provisions of Section 19 of "The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act. 2013". And under the provisions of Section 21 of "the Act ibid", public notice is made To Whom It May Concern, that the Government intends to take possession of the land. That the claims to compensation and Rehabilitation and Resettlement for all interest in such land along with their objections, if any, to the measurement made under Section 20, be made to the Land Acquisition officer-cum SDM, Lopoke within 30 days from the date of publication of this notice.

Mines of coal, iron-stone, slate or other minerals lying under the said land or any particular portion of the said land, except such parts of the mines and minerals which may be required to be dug or removed or used during the construction phase of the project for the purpose of which the land is being acquired, as not needed.

A plan of the land may be inspected in the office of the Land Acquisition Officer-cum-SDM, Lopoke and Tehsildar Lopoke on any working day.

A summary of the Rehabilitation and Resettlement Scheme is appended.
