

Proceeding of the meeting of Social Impact Assessment Appraisal Committee (SIAAC) held on 26.05.2021

Video conference of Expert Group member was held on 26.05.2021 as per provision of section 7 of "The right to fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013", for acquisition of 30 acres of land for public purpose for the establishment of Post Graduate Institute of Horticulture Research and Education (PGIHRE), a "project for Government administered, Government aided educational and research schemes or institutions" in village-Chhiddan, Hadbast No. 333, Sub-Division-Ajnala, District- Amritsar, Punjab were held under the chairpersonship of Prof. Rajesh Gill, Panjab University, Chandigarh. It was informed that as per "The Right to Fair Compensation and Transparency in Land Acquisition and Rehabilitation and Resettlement Act, 2013", Guru Nanak Dev University has been notified as Social Impact Assessment (SIA) Agency for Government of Punjab. The work of Social Impact for completion of SIA Study for acquisition of 30 acres of land for public purpose for the establishment of Post Graduate Institute of Horticulture Research and Education (PGIHRE), a "project for Government administered, Government aided educational and research schemes or institutions" in village-Chhiddan, Hadbast No. 333, Sub-Division- Ajnala, District-Amritsar, Punjab was awarded to SIA Agency, Guru Nanak Dev of University, Amritsar. The SIA Agency, GNDU, Amritsar submitted the SIA study report to Nodal Officer, Horticulture Department, Punjab Govt. on 23.04.2021. Dr. Rajesh Kumar, Principal Project Coordinator, SIA Agency, Guru Nanak dev University, Amritsar gave the presentation on the SiA study report as below:-

Project and Public Purpose:-

One of the objectives of the Social Impact Assessment study is to examine the nature of the proposed project, whether it is a public purpose project or not. It is to prove that the proposed acquisition of 30 acres of land for public purpose for the establishment of Post Graduate Institute of Horticulture Research and Education (PGIHRE), a "project for Government administered, Government aided educational and research schemes or institutions" in village-Chhiddan,

Hadbast No. 333, Sub-Division- Ajnala, District- Amritsar, Punjab serves the public purpose clause as under RFCTLARR 2013, besides understanding that land acquired is bare minimum needed for the project.

Keeping in the view the above issues, it is in the public interest to go ahead with the acquisition of 30 acres of land for the establishment of Post Graduate Institute of Horticulture Research and Education (PGIHRE), in village-Chhiddan, Hadbast No. 333, Sub-Division-Ajnala, District- Amritsar, Punjab. The SIA study on the basis of public hearing, documents of revenue department and field study found that 30 acres of land notified for acquisition belongs to 'one family' of the village only. Henceforth, there is no need for independent Social Impact Mitigation Plan (SIMP).

Study of Alternative Proposals:-

In the light of above facts and 'one family' falling in the category of project affected families (PAFs) involving negligible displacement, there is no need to study alternative.

Project Area: Loss of Land:-

The proposed acquisition of 30 acres of land as per layout plan is for public purpose for the establishment of Post Graduate Institute of Horticulture Research and Education (PGIHRE), in village-Chhiddan, Hadbast No. 333, Sub-Division- Ajnala, District- Amritsar, Punjab under RFCTLARR 2013.

Observations made by Experts Committee

After the detailed presentation and discussion, following are some of the observations of Social Impact Assessment Appraisal Committee (SSIAC). The members expressed their satisfaction over the contents of the SIA study report which contained detailed analysis of the social impact assessment upon the stakeholders. The expert committee members made certain observations/recommendations which are discussed as under for the information of the Government.

After detailed deliberation the expert committee decided as under:-

- Adequate compensation must be given to the land owners, i.e., project affected families. 1)
- Preference may be given to the residents of Chhidan Village in employment generated by 2) PGIHRE.
- Members recommended that reservation of seats and fee concession may be ensured for 3) the youth residing at Chiddan village in admission to various courses at PGIHRE.

- During acquisition, small leftover parcels of land may be considered as far as possible within provision of the Right to fair Compensation and Transparency in Land Acquisition and Rehabilitation and Resettlement Act 2013.
- The committee recommends acceptance of the SIA-PGIHRE report and initiation of further necessary action for acquisition of 30 acres of land for completion of PGIHRE project.

The expert Group constituted under section 7, sub-section 1 of the Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation and Resettlement Act, 2013 has opined that:

Recommendations:-

The expert group is of the opinion that the setting up of proposed PGI-HRE which has been delineated in section 2(i)-e(Planned Development) of "The Right to Fair Compensation and Transparency in Land Acquisition and Rehabilitation Act, 2013", it serves the public purpose. While doing appraisal of the SIA study report the committee has found that the land proposed for acquisition is bare minimum.

The SIA study report ascertains that the potential benefits of the project outweigh the social cost and adverse social impacts.

In the light of above-mentioned facts, the case is recommended to the Government of Punjab to proceed for acquisition of acquisition of 30 acres of land for public purpose for the establishment of Post Graduate Institute of Horticulture Research and Education (PGIHRE) in village-Chhiddan, Hadbast No. 333, Sub-Division- Ajnala, District- Amritsar, Punjab as per provision of "The Right to Fair Compensation and Transparency in Land Acquisition and Rehabilitation Act, 2013".
