

# **PUBLIC NOTICE**

## **GOVERNMENT OF PUNJAB DEPARTMENT OF AGRICULTURE & FARMERS WELFARE PUNJAB STATE COUNCIL FOR AGRICULTURAL EDUCATION**

Government of Punjab has setup the council under the provisions of The Punjab State Council for Agricultural Education Act, 2017. The council has been empowered to specify the minimum standards and guidelines for imparting agriculture education and training to be followed by Colleges & Universities in the State of Punjab and to regulate the Agriculture education through grant of recognition to colleges/institutions/departments that meet the norms and standards to run the agriculture education programmes.

As per the provisions of the Act, all the institutions running programmes related to agriculture education were to submit a status report with regard to affiliation, admission, curricula, staff etc. to the council within 30 days and a compliance report within six months, so as to seek approval of council within two years from the date of commencement of this Act. The Act was notified on 2 January, 2018. However, by granting extensions in time period, all the institutions were requested to fulfill the conditions as prescribed under the Act till June 30, 2022.

This is for the information of general public that the following institutes offering education in the discipline of agricultural sciences fulfill the minimum standards prescribed by the council regarding B.Sc. (Hons) Agriculture programme till May 31, 2024.
