## Seed Act, 1966& Seed Control Order, 1983

## **ISSUE / RENEWAL OF SEED LICENCE**

The following documents are required for the issue/renewal of seed Licence:-

1. Application form 'A' in duplicate for the issue of New Licence.

2. Application from 'C' in duplicate for the Renewal of seed Licence within the validity period.

3. The photographs of the applicant/owner/firm/company duly attested by the concerned Chief Agricultural Officer of the district.

4. Applicant's PAN number and proof of permanent residence.

5. Affidavit on stamp papers worth Rs. 25/- duly attested by the Notary or Ist Class Magistrate.

6. Affidavit on Rs. 5/-for responsible person under seed Act duly attested by Notary/Ist Class Magistrate.

7. Principal Certificate/source Certificate from whom/where the breeder/foundation seed is obtained.

8. Map of Store/Godown duly verified by the concerned ADO/AO and counter signed by the Chief Agriculture Officer.

9. Fee of Rs.50/- to be deposited in the office of Director of Agriculture at state level and in the office of Chief Agriculture Officer at district level.

10. List of dealers.

11. Copy of Partnership Deed.

12. Memorandum of Company.
